Our Aims ...

To involve key local stakeholders in the development of the Outer Dowsing Offshore Wind project (landfall, onshore cable route and substation) through presentations and discussions.

To act as a two-way communication channel between local communities and the project team.

To help foster local involvement and ownership of the project.

To ensure focused discussions and ensure the CLGs achieve their goal, it is encouraged that representatives bring forward the views of their communities. It is also encouraged to focus the conversation on local issues



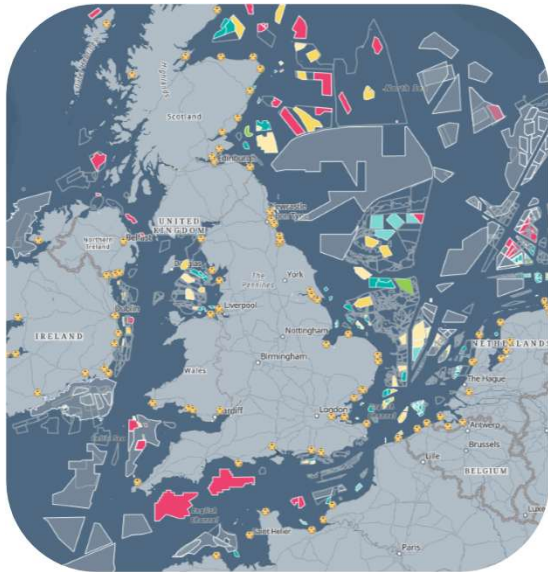

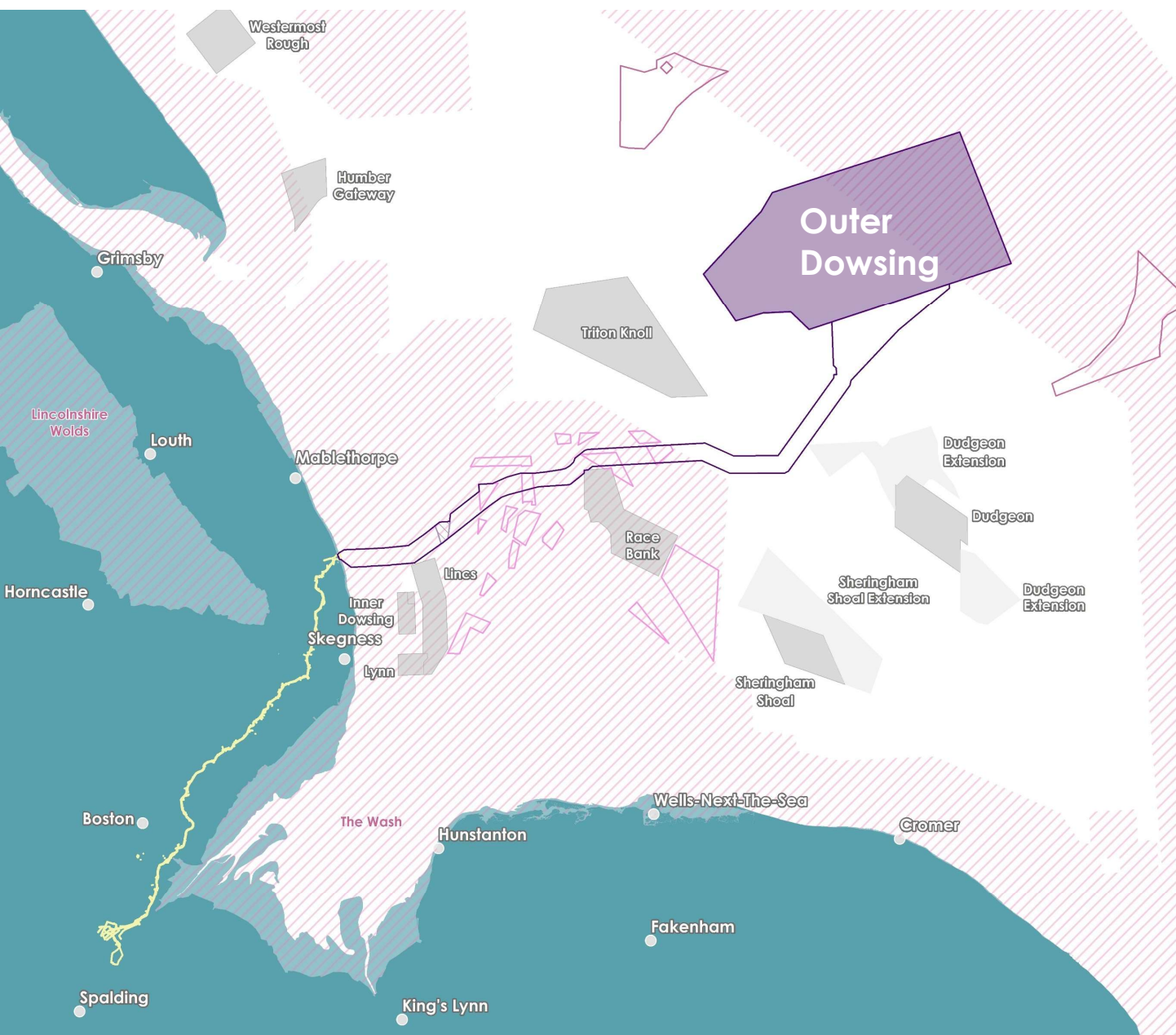
Where will the Outer Dowsing wind turbines be built?

Interactive map



The offshore elements of the Project consist of an offshore wind turbine array with up to 100 turbines located approximately **33 miles (54 km)** east of the Lincolnshire coast, along with offshore platforms, export cables, array cables and infrastructure.

Onshore the project will reach land at Wolla bank and go south via **underground cable** to a substation in Surfleet Marsh.



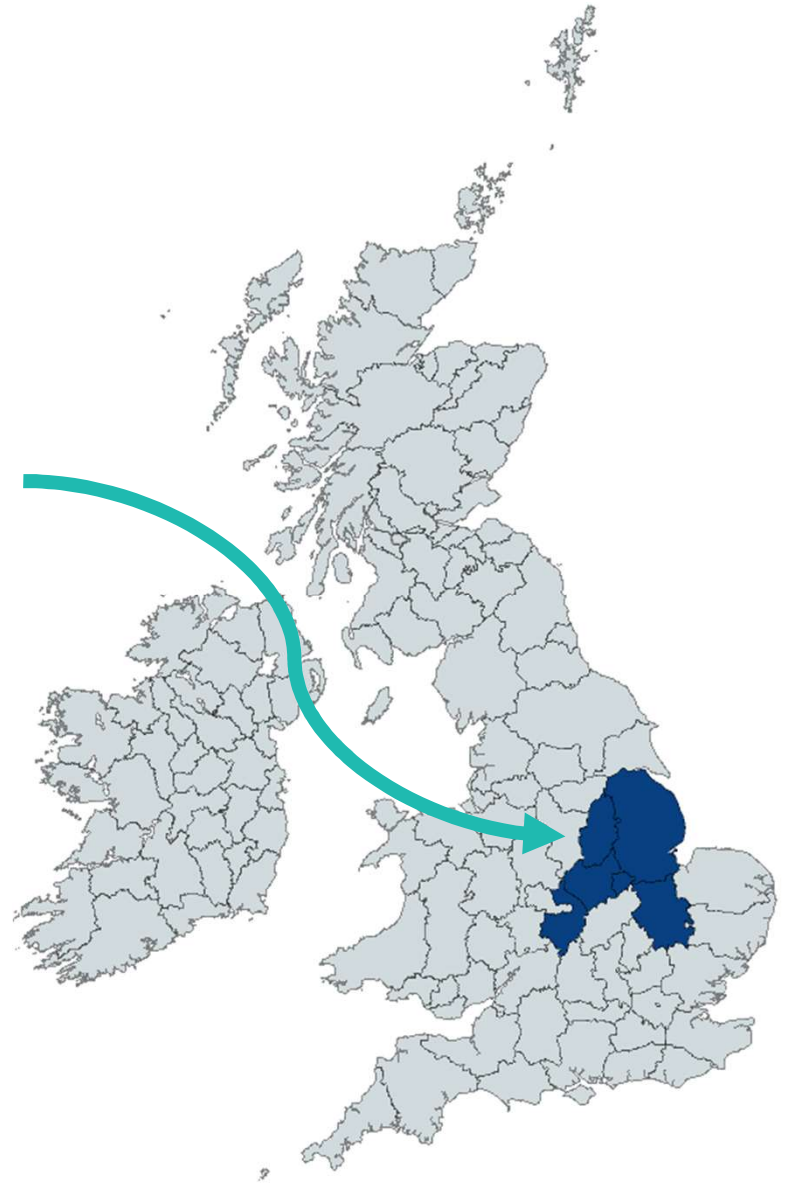

Outer Dowsing Offshore Wind will produce 1.5 GW, equivalent to power used by

1.6 million homes

Enough to power 80% of the homes in East Midlands or all the homes in Lincolnshire, Leicestershire, Nottinghamshire, Warwickshire and Cambridgeshire and Rutland.

In 2024, **30% of UK electricity demand** was met by wind powered turbines, more than was generated by gas fired turbines (26.4%)

The Road to 1.5GW

Project launch

Preferred bidder status secured in 2021, team assembled.

Surveying and designing

Five seasons of onshore and offshore surveys.

Procurement

Procuring assets and services, out to market for main asset packages.

Consultation

Five rounds of consultation preparing for DCO. Moved the onshore cable route and adapted project.

Consent to build

18 months of examination and determination. Decision granted Feb 2026.

Next steps...

Secure a CFD, Project finance and prepare for construction



Consent Granted

What does it mean for the community now the Development Consent Order (DCO) has been granted?

- The DCO award means the project has been formally approved by Government. The decision on whether it can go ahead has now been made.
- Construction will not start yet. There is around a 20-month period before main works begin.
- The next phase is about preparation, not construction. This includes detailed design, further survey works and agreeing detailed plans with the local authority.
- Managing impacts like traffic, noise and disruption is a requirement of the DCO. Detailed plans will be agreed before construction starts to reduce impacts on local people as much as possible.
- We will continue to keep the community informed throughout this period and in the lead up to construction.

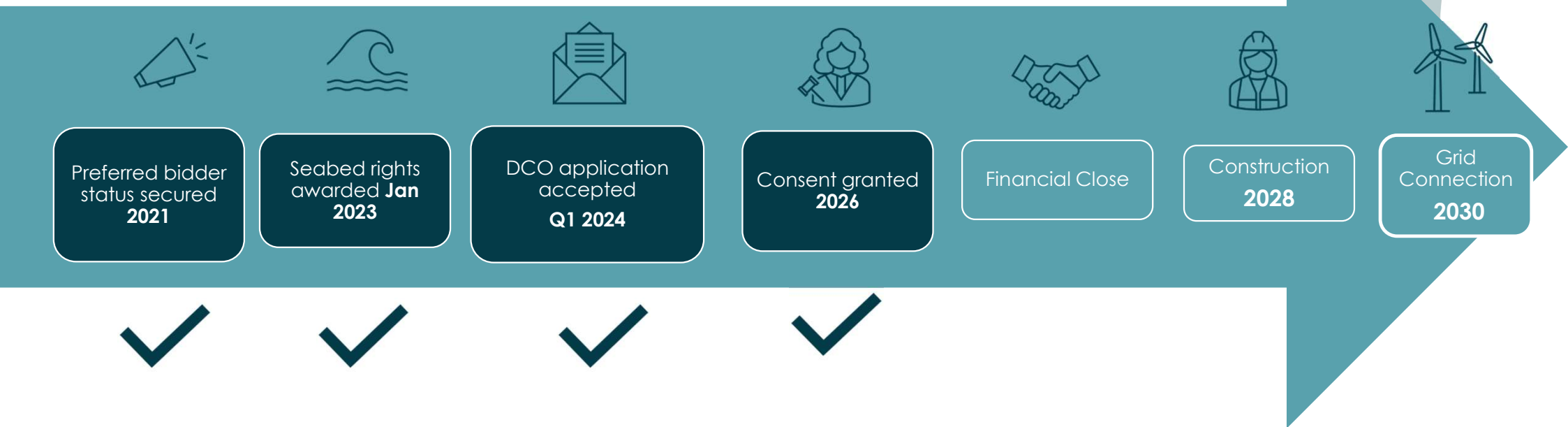

The Outer Dowsing Offshore Wind project completed the Examination phase in April 2025 and has now successfully been awarded DCO consent by the Secretary of State on 10th February 2026.

Looking ahead, the project will be continuing with various surveys in the run up to starting construction. Construction will now commence in Q1 2028 at the earliest and the timeline shown provides indicative dates for various milestones that are important to landowners and tenants.

Heads of Terms

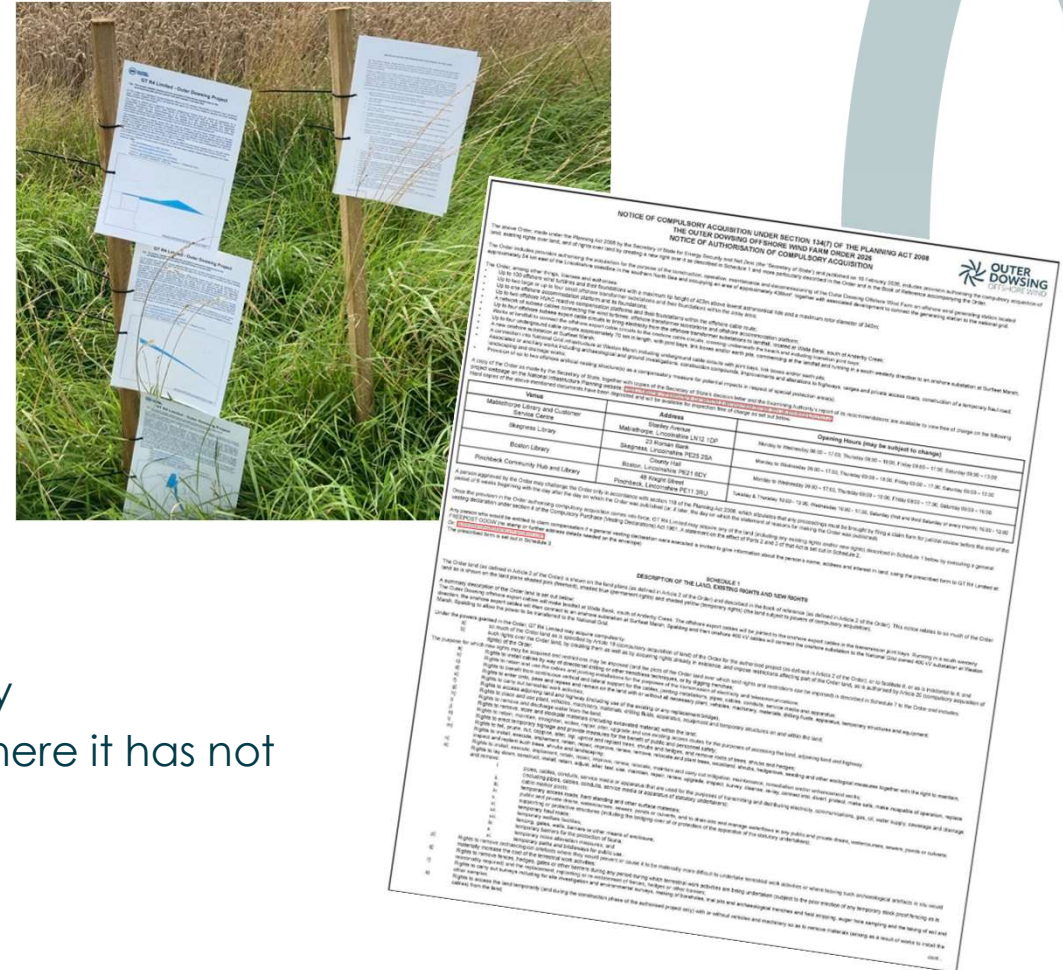
- Majority of landowners along the route have signed Heads of Terms with the project

Option agreements

- Nearly two thirds of landowners have signed option agreements

Landowners with Option in place

- ODOW's preference is to secure rights voluntarily
- Compulsory acquisition will only be exercised where it has not been possible to reach a voluntary agreement



Archaeological trial trenching

Overview:

- Nearly 400 trenches excavated
- Majority of trenches had no archaeology

What we found:

- Postmedieval ditches
- Near Hogsthorpe – potential Iron Age archaeology including intact horse and cow skulls and pottery
- Near Old Leake – potential intact Roman pottery
- Near Addlethorpe – potential medieval pottery
- Near Croft – potential Salt-working activity

Future Survey Plans

Archaeological

A campaign of archaeological trial trenching will be undertaken in 2026. Works will comprise the excavation of approx. 200 trial trenches predominantly between Friskney and Fosdyke in agreement with Lincolnshire County Council and Historic England.

Geotechnical

In and around the landfall construction compound, located in farmland south of Anderby Creek, ODOW will be installing boreholes to assess ground conditions and monitor groundwater levels.

Outer Dowsing Energise Workshops

We have offered workshops free of charge to 14 secondary schools and over 40 primary schools.

Supergrid challenge

pupils build their own wind turbines and investigate the impact of design variables on the efficiency of a wind turbine. They then compete in teams to generate the most energy from the wind.

240 children have benefitted so far

Wind Power Challenge

Pupils build their own wind-powered machines to lift weights, learning the critical elements of scientific investigation, design, record keeping, teamwork and problem solving.

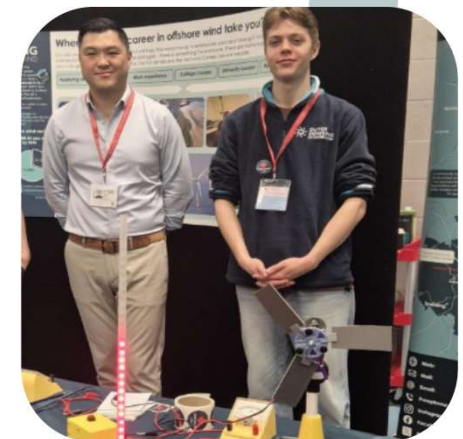

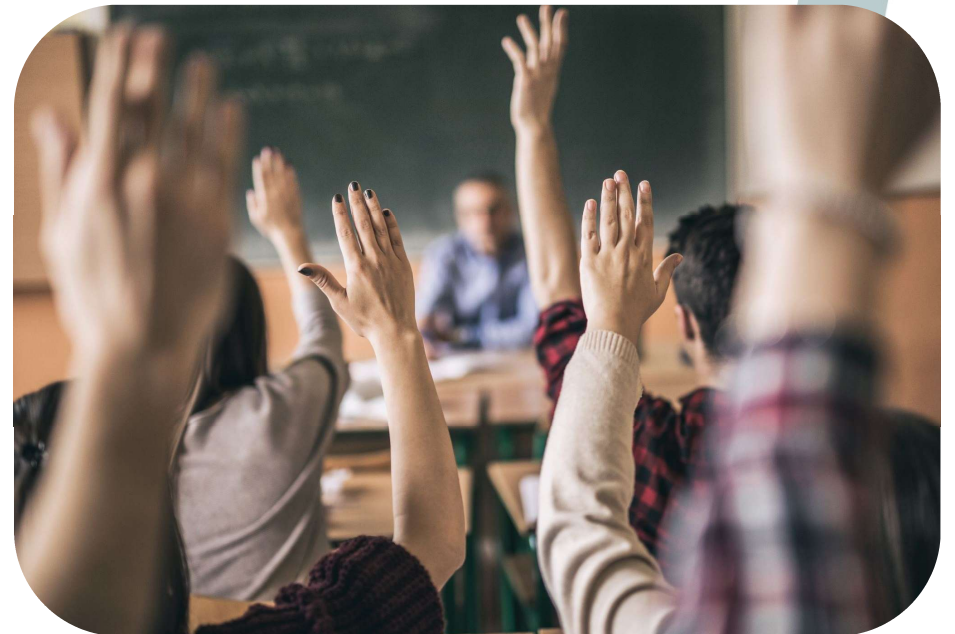


Friskney Primary Outdoor Learning Programme

- Selection committee to be formed and looking for some volunteers. Aim to have them on seat for next meeting.

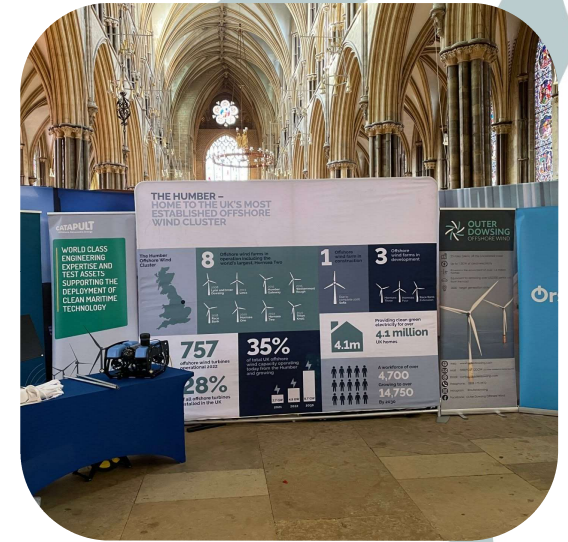
